IMPORTANT INFORMATION FOR OPENING A NEW ACCOUNT

I understand that for joint accounts, "I" refers to all account owners, and each of the account owners agrees that any account owner has authority to act on the account without notice to the other account owners. The Green Century Funds, at their sole discretion and for their protection, may require the written consent of all account owners prior to acting upon the instructions of any account owner.
