#### **INVESTOR PRIVACY NOTICE**

# FOR GREEN CENTURY FUNDS INVESTORS RESIDENT IN THE EUROPEAN UNION AND THE UNITED KINGDOM

Date: May 25, 2018

This notice (the "Notice") is provided by *Green Century Capital Management, Inc., 114 State Street, Boston, MA 02109* ("Green Century", "us" or "we"). This Notice is addressed to any natural person who is resident in the European Union and the UK who is a shareholder in any fund managed or advised by Green Century (a "Green Century Fund"), ("you") whose personal data Green Century collects and controls in the conduct of its business.

This Notice gives information regarding your personal data (as defined under the Privacy Laws (defined below)) and describes the basis on which we process your personal data, for what purposes, your privacy rights under applicable privacy laws including the General Data Protection Regulation ("GDPR") and other UK and European data privacy laws (the "Privacy Laws") and how we protect your personal data.

#### The personal data that we collect

In the conduct of our business, we obtain personal data about you including, without limitation, your name, date of birth, address and other contact details, social security number, tax or other identification number, identity documents and information on transactions in your Green Century Funds accounts. This information may come from sources such as an account registration form, or other forms or material completed or supplied by prospective or current Green Century shareholders, or other written, electronic or verbal correspondence which relate to transactions by you or on your behalf.

## How we use personal data

We collect your personal data to fulfill our contractual obligations, our statutory obligations and/or the legitimate interests of Green Century and for other purposes for which Green Century has a lawful basis under the Privacy Laws, including: (i) for compliance with legal and regulatory requirements such as regulations aimed at prevention of money laundering or terrorist financing or "Know your Client" requirements, as well as to verify the status and / or eligibility of Green Century shareholders for funds or services offered by Green Century and for compliance with tax reporting requirements, (ii) for purposes of reporting to, or communicating with, Green Century

shareholders concerning their investment in the Green Century Funds; (iii) in connection with our investment activities, including investment due diligence or investment monitoring activities or in response to "Know your Client" requirements of counter-parties; (iv) in connection with litigation, investigations, regulatory or governmental enquiries or for other legal or regulatory purposes involving Green Century, the Green Century Funds or Green Century shareholders, and (v) for other legitimate business interests.

In addition, we may, with your consent, process your personal data in order to communicate with you for marketing purposes. In this event, we may provide additional information that we believe may be of interest, including about the Green Century Funds, Green Century's advocacy work or other services, news updates, research or market commentary, conferences, or events offered by or in conjunction with Green Century. You have the right to unsubscribe when you have provided your consent to receive these communications by emailing info@greencentury.com or by following the instructions in any such communication, e.g. by clicking on the link to unsubscribe. Green Century will retain in accordance with its data retention policy your personal information only for as long as is reasonably necessary to achieve the purposes for which it is collected.

### The disclosure of your personal data

We may share your personal data with Green Century entities including with Green Century Funds for any of the purposes set forth above.

We may share your personal data with third parties for any of the purposes set out above, including:

- Service providers *e.g.*, attorneys, auditors, accountants, administrators, custodians, depositaries, distribution managers and brokerage firms, event organizers or other agent, adviser or service provider of any Green Century Fund or Green Century shareholder.
- Other counter-parties *e.g.*, managers, general partners or investment advisers or administrators or any of their respective agents or representatives.

Where your personal data is processed by third parties outside the UK/EEA, we will ensure appropriate safeguards are in place to adequately protect it, as required by applicable law.

#### Security

We take seriously the obligation to safeguard your non-public personal data. We maintain physical, electronic, and procedural safeguards to protect against unauthorized access to your information. Details of our IT security measures are set out in our Comprehensive Written Information Security Program and our Information Security Policies and Procedures.
